Member Advisory Boards & Community Member's Updates	Adult and Aging Commission: No report. Alcohol and Drug Advisory Board: Melinda Avery reported: They had a great meeting last night and they talked a lot about ways to reach out into the community and involve other people. Their board is going to appoint an Ad-Hoc Committee to approach the Mental Health Advisory Board to work together on the impacts of the ACA. Focusing on people who wake up and say they need help but do not know where to go to get the help. Children's Coalition: Ernie highlighted report included in meeting packet. Disability Advisory Committee: David Mana-ay reported: A monthly update report has been sent to HSCC staff and will be forwarded to the group via email and will be included in the monthly update reports posted on the HSCC website. DAC's December meeting is on the first Tuesday of December at 5:30pm it will be one third work and two thirds festive food eating and everyone is invited. There has been intensive work continuity on the housing element with Lori Moss, Director for the Department of Community Development and Chris Jensen from the DAC's Housing Subcommittee and this will be discussed at the meeting. Mental Health Advisory Board: Report included in meeting packet. Public Health Advisory Board: No report. Community Members: Addie Ellis shared a concern. The Wind Youth Center, the only youth center in the six county region that serves as a drop in center for homeless youth between the ages of 12-24, was going to have to close the drop in center due to its funding being drastically reduced but due to an outpouring of community support the doors will stay open through the holidays and then revisit the situation in January. There are only 12 available beds for respite but the need far exceeds this and the community needs to come together to help the situation.

North A Safety Concerns

- DHA is working with Loaves and Fishes to accept referrals for the Homeless Return to Residence program. This program allows homeless individuals to return to the former residence if the met certain program requirements.
- DHA has been working with of concerned community members concerning the continued problem o loitering along the North A corridor. The problem has escalated with individuals using the bathroom on and near the building on North A and the businesses in the area. The workgroup is looking for solutions to reduce the incidences of loitering and other visitors being accosted when visiting the area. There is discussion on putting a perimeter fence from the Quinn Cottages down to around the Men's Shelter on the grassy area.

Affordable Care Act (ACA)

■ DHA since October 1st (First date of Open Enrollment for ACA) has received 7,732 new Medi-Cal only applications, and 726 applications that will be eligible January 1, 2014.

Family Emergency Shelter Service Redesign

DHA will host two stakeholder meetings that will focus on the redesign of the CalWORKs funding for the family emergency shelters. The three family emergency shelters that receive CalWORKs funding are St. John, Next Move (Formerly Sacramento Area Emergency Housing Center), and Volunteers of America. The goal is to redesign to focus more on Rapid Rehousing and Employment. The first meeting is tentatively scheduled for November 21 and the second will be held on December 17. DHA also has discussed the redesign in a number of Sacramento Steps Forward sponsored homeless services committees.

Domestic Violence Trust Fund Work Group Report to HSCC November 14, 2013

BACKGROUND: The County Department of Human Assistance (DHA) administers funds intended for Domestic Violence (DV) shelters and supportive services for programs who meet the state criteria. The funds come from marriage license fees. The funds are also to be used to address the needs of underserved populations, including people with disabilities, non- or limited English speakers, cultural groups that may be isolated, members of the LGBTQ community, among others. The primary statewide funding comes from the CA Governor's Office of Emergency Services. The Welfare and Institutions Code requires that the allocation of the county's DV Trust Fund monies be determined by a group of community experts who will develop a process for recertification and funding allocation.

STATUS: The DV Trust Fund work group was convened on October 10 and October 29, 2013. Representatives included the Department of Human Assistance, the District Attorney's Office, the Disability Compliance Office, the Human Services Coordinating Council (HSCC), Department of Health and Human Services Senior and Adult Services, and the three qualified Sacramento area DV providers WEAVE, My Sister's House, and A Community for Peace.

The group reviewed the legal requirements under the Welfare and Institutions Code. Although the funding allocation is divided between Core and Discretionary requirements, the DV providers pointed out that they are mandated to meet all of those requirements, so in the discussion they were all treated as Core Requirements. The total amount of funding to be distributed for FY 14/15 is \$230,704. The group weighed the options of dividing the funds equally amongst the three agencies, or by the number of beds provided. The two smaller agencies pointed out that per the establishing legislation, the funds were intended to be distributed equally because of the particular needs of those they served, such as transportation and cultural services, made their per capita costs higher. However, after doing the math, it was determined that dividing the funds equally would cut WEAVE's bed count nearly in half. While no one was entirely comfortable with the decision, the final determination was that the least harmful impact with regard to reduction of services would be achieved by allocating the funding by bed count. Unfortunately each agency still experienced a substantial reduction of funding. This is the recommendation that will be presented to the Board of Supervisors for their consideration next month.

NEXT STEPS: The DV Workgroup unanimously concurred that the amount of allocated funding is deplorably insufficient to meet the needs of these agencies and the communities they serve. Because there was not even sufficient funding to maintain existing services, there was no opportunity to consider the needs of people with disabilities and the remaining identified underserved groups. Members agreed to reach out to their respective contacts and resources to identify possible additional funding streams. The Access and Functional Needs Community Advisory Group will consider making this a part of their 2014 work plan and the Disability Advisory Commission has reviewed this issue and will consider further action as well. There will be opportunity for public input at the upcoming Board of Supervisor's hearing. The DV Trust Fund Work group will reconvene in the future as warranted.
