#### DHA Report to HSCC October 9, 2014

- The Department is currently in the process of hiring and training 57 new Eligibility Specialist for the Affordable Care Act (ACA)/Medi-Cal programs.
- Open Enrollment for ACA begins on November 15, 2014.
- Working on collaboration with California Department of Corrections and Rehabilitation to place staff at the Folsom State Prison Facility. The staff will determine eligibility for CalFresh, Medi-Cal.
- Through AB82, the Department of Health Care Services has made funding available to California counties to provide Medi-Cal Outreach and Enrollment activities statewide with emphasis on the following populations:
- o Persons with mental health disorder needs
- o Persons with substance use disorder needs
- o Persons who are homeless
- o Young men of color
- Persons who are in county jail, in state prison, on state parole, on county probation, or under post-release community supervision
- o Families of mixed-immigration status
- Persons with limited English proficiency

The Department of Human Assistance (DHA) was awarded \$898,174 of these funds to implement a countywide Medi-Cal outreach, enrollment, and retention assistance program. Through an RFP process, DHA awarded \$855,000 to ten local community- based organizations to provide these services.

I'll be at the annual meeting of the California Welfare Directors Association this week and will miss the HSCC meeting.

Two updates for you this month:

- I've finally filled the position of Deputy Director of DHHS for Finance, Contracts, and Administration. It's a promotion for Luis Villa, who many of you know from his many years of service at CPS. Please congratulate him and feel free to start contacting him on budget and contract matters.
- The Board of Supervisors voted unanimously to join the State's Title IV-E Demonstration Project (aka "IV-E Waiver") which will significantly change the way that CPS and foster care and juvenile probation services are funded. Instead of an uncapped entitlement (the Federal funding grows when more kids go into out-of-home foster or group home placements), the County will get a capped grant that can be used much more flexibly. (When kids are reunited with their families or adopted, the Federal funding does not diminish and can be used to support families when kids are no longer in foster care or to prevent kids from going into foster care.) This represents major new opportunities for DHHS, Probation, and DHA.
  - There will be an educational meeting to brief the community about the Title IV-E demonstration project on Tuesday, October 28 from 4:00 7:00 p.m. at the Board of Supervisors Chambers, 700 H Street. Leaders of the three departments will describe initial program plans aimed at decreasing out-of-home placements, engaging families in individualized case planning, and decreasing recidivism and delinquency among youth on probation. There will be an opportunity for community participants to provide input on our plans and priorities, including ways to re-invest the savings as the costs of placement come down during the 5 years of the project. #### **AAC Reports**

#### Chair's Discretion

• Meals on Wheels report given by David Morikawa. This past fiscal year was difficult with securing finances due to sequester and other funding issues, currently serve about 465,000 meals per year, currently at 1,240 home deliveries in Sacramento County (maximum is 1,150 to realistically sustain), may have to utilize a waiting list, this year started serving about 40,000 meals in Western Placer County, has required program to stretch costs to meet these needs. Program features have changed to provide salads along with meals twice a month. Have 520 routes, 25 of which are covered by paid staff, the rest is managed by volunteers. Nutritional information is available with the meals.

#### Committee Reports

- Oversight- (Al Kahane) —Handouts were distributed pertaining to language used by county personnel in determining dependent adult status as well as California legislative information that was received by the committee during the case review meeting in August.
- PROD- (Gary McDonald) committee has been working on the 2015 Program of Work and have it approximately 90% completed.

#### **Focal Point reports**

• Samuel and Bonnie Pannell Community Center – Laura Bjornsen, Superintendent of Community Centers, and Jennifer Winscott, Program Supervisor, gave a report about the center. Center is a recreational facility that serves all ages. Classes, clubs and activities include Tai Chi, "Fit Over Fifty" aerobics, walking, language (Spanish), Bridge, Bid Whist, computer skills, crafts, ceramics, and an All Seasons café (provided through Meals on Wheels by ACC) for lunches. Transportation includes Paratransit, Regional Transit, as well as a shuttle bus from Molina Medical. "Eat Well, Live Well" pilot program (grant funded), meets for four weeks, will have two meetings a week which includes cooking demonstrations, nutritionist and exercise specialist to give presentations, and has been very successful. Do It Yourself workshops for various home improvement projects are open to all ages.

• At our regular meeting on October 8, 2014, the Alcohol and Drug Advisory Board will host an Informational Forum on Proposition 47, a voter initiative for the November 2014 California ballot that will reduce the penalties for non-serious, non-violent property and drug crimes from felonies to misdemeanors and direct financial savings to K-12 schools, mental health and substance abuse treatment, and victim services.

On October 1<sup>st</sup> the Access and Functional Needs / Coordination Advisory Group Core Team held a conference call at 10:30 am – Call minutes follow below:

Access and Functional Needs Coordination Advisory Group

October 1, 2014 Conference Call – Minutes

- ~ Follow up on 2013/2014 goals: Reviewed the following goals (established in November 2012) and status through October 1, 2014.
- build a strong foundation of support and communication between government and citizens with AFN; The
  team continues to build relationships and networks with community partners providing services to people
  with access and functional needs. Training opportunities and emergency planning feedback opportunities
  have been provided to a variety of community partners/members providing services to people with access
  and functional needs. The issue is with 'engagement' in these opportunities by a wider variety and greater
  number of community partners. Since the team started (November 2012), they have invited various
  members of the community to participate in quarterly meetings. Approximately 65 community partners are
  included in quarterly meeting invitations and training notifications. Only a small percentage (less than 20%) of
  those agencies / community partners participated in the meetings / training opportunities. STATUS:
  Ongoing; need to engage community partners and stakeholders this has been the ongoing dilemma.
- review and evaluate emergency plan documents;
  - During the community partner meetings held, various Board approved emergency plans were shared with the group. At every meeting, the meeting participants were provided a copy of the County's webpage listing all 'approved' emergency plans. The group was asked to review said plans and provide feedback, concerns, etc., to the Office of Emergency Services (contact info provided). **STATUS:** Need more engagement by community partners.
- advise the Office of Emergency Services (OES) of preparedness and response issues that impact PAFNs;

Nothing from the community partners (outside of government agencies) has been provided to the Office of

Training was recently provided to transportation providers and first responders (government and private) regarding communication and emergency transportation for people with access and functional needs.

Emergency alert and notification migrated from a Reverse 9-1-1 system to an Everbridge system with self registration.   - o participate in community emergency exercises and drills the County OES hasn't designed any community type exercises or drills in the past nine months, however members of OES are participating on exercise design teams for exercises to be scheduled in 2015 (American Red Cross). If the exercise includes the community (volunteers), and particular elements are being exercised, outreach will be made to the community partners servicing people with access and functional needs for participation in the exercise / drill;
  - availability of community-based emergency preparedness programs and trainings a variety of non-profit agencies (e.g., American Red Cross, Salvation Army, R.S.V.P.-N.E.T. Program) provide training opportunities and emergency preparedness programs to the public;
  - evacuation and accessible transportation concerns The County's Evacuation Plan (2008) is on the County's website: <a href="http://www.sacramentoready.org/Pages/default.aspx">http://www.sacramentoready.org/Pages/default.aspx</a>
     The plan is due to be updated in 2015. The Transportation Annex (draft) is an annex to the Evacuation Plan. Annexes are not typically posted on the County's website as they are standard operating guides tools used by the Emergency Operations Center (EOC) on managing resources. The Annex is not considered an emergency plan, rather a guidance for responders in the EOC;
  - media coordination to ensure emergency information is provided in a manner that is fully accessible and inclusive – Ongoing; in 2013 – County CMO, City of Sacramento CMO, and CalOES OAFN met with local broadcast stations to advise of need for 'all inclusive' broadcasting of emergency

OAFN regarding communications and emergency transportation – audience of first responders and transportation providers. More work needs to be done in this area.
