Action Item – HSCC ARPA Recommendation	Sacramento County will receive its second allotment of ARPA (American Rescue Plan Act) funding. HSCC leadership is interested in drafting a letter to the Sacramento County Board of Supervisors regarding possible budget priorities to be addressed. Possible areas of need include: permanent social housing, food, mental health services, substance use programs, neighborhood outreach, power building and support.  Motion to create an ad hoc committee to develop ARPA message to the Board for review at June HSCC meeting.
Wellness Crisis Call Center and Response Update	The WCCC is still on track for a July 1, 2022, launch. Current priorities are recruitment and hiring staff.
Chair Report	As of June, the HSCC will begin meeting in person. We are looking at the Dept. of Human Assistance site at 2700 Fulton Avenue. Will look at the possibility of conducting hybrid meetings.
