
	asked R. Hoskins and D. Bonner if they will accept being nominated. Commissioners will vote in May.
Approval of 2021 Annual Report (see draft attached)	C. Koss shared via Zoom draft copy of annual report for all to view. Commissioners and guests provided positive feedback on report. C. Koss requests a vote to make this a final. A. Carni moved to approve, R. Hoskins second the motion. The motion passed with no objections or abstentions for approval of 2021 annual report.
Board of Supervisors Resolution declaring May 2022 as Older Americans Month (to be presented at May 10 BoS meeting)	C. 

- ► Raise visibility about the full range of public and private LTSS programs available.
- ► Expand person-centered services.
- ▶ Implement the No Wrong Door System.

# How Consumers Navigate Current System



#### No Wrong Door System

#### ▶ What It Is

► No matter which extended partner is contacted, the person will receive efficient access to a wide array of information about LTSS.

#### ► Why It Is Important

- Empowers individuals to make informed decisions, to exercise control over their long-term care needs, and to achieve their personal goals and preferences
- ► Serves anyone seeking long term services and support, regardless of age, income or disability

# The 4 Core Services



# Enhanced Information & Assistance (E I&A)

- ► Provides access to E I&A through multiple points of entry and a warm hand off.
- ► Alliance of Information and Referrals Systems (AIRS) certified staff.
- ► Provides comprehensive and trusted information to people of any age, disability type and income level/source.
- ► Includes follow-up to ensure quality referrals.

## Person-Centered Options Counseling

► Counseling provided by trained staff using personcentered practices that provide consumers guidance and assistance in their deliberations to make informed choices about LTSS.

#### **Short-Term Service Coordination**

- ► Personalized service coordination for the purpose of stabilizing a situation for individuals whose health, safety and welfare are at risk.
- Assistance to prevent unnecessary admittance to emergency department or institutional placement.
- Usually lasts 90 days or less.
- ► After stabilization of consumer's emergency, referral to options counseling for LTSS planning is available.

#### Person-Centered Transition Support

- ➤ Supports a person with information, decision support and coordination of multiple services in order to successfully move from a health care facility back to a community home.
- ► Includes both hospital/acute care to home, as well as nursing facility to home.

#### What They Do

- Provide at least one core service of the ADRC
- Provide person-centered services
- Participate as Advisory Committee member

#### Why They Are Important

- ► Enhance awareness of and access to public and private programs/services for Sacramento County consumers.
- Streamline consumers' access to services through shared program intake, application assistance, service provider information, and staffing and funding resources.
- ► Expand Resources for each partner organization.



### Sacramento County Adult and Aging Commission 2021 Achievements and Activities

#### **Supporting City & County Age- Friendly Initiatives**

The Commission served as a resource for local officials seeking input and advice on how to make our community more age-friendly.

Staff from the City of Sacramento Youth, Parks, and Community Enrichment Department attended the February Commission meeting to get input on the city's Parks Master Plan.

Several Commissioners served on the City of Sacramento's Age-Friendly Stakeholders Group to help the city develop its Age-Friendly Action Plan as part of the process of joining the AARP Age-Friendly Network.

Towards the end of 2021, the Commission began working with county staff on organizing listening sessions to inform the county's Age-Friendly Action Plan. Thanks to Patty Wait for serving as the liaison between the Commission and county staff.

#### New Sacramento County Online Aging Resources Directory

In partnership with the Sacramento State
University Gerontology Department, the
Commission launched a new online directory of
local, state, and federal resources for older adults
and caregivers. Gerontology students and faculty
developed over 50 pages on topics ranging from
affordable housing to veteran programs. The
website includes listings for hundreds of non-profit
and government agencies. The directory is located

To fulfill its role of raising public awareness of available programs and services, the Commission will continue to work with the CSUS Gerontology Department to maintain and grow this resource directory.

#### Commission Priorities for 2022-2023 County Budget

The Commission appreciated the opportunity to share its priorities for the 2022-2023 budget. The Commission identified the following priorities:

- Flexible funding for older adults facing financial crises that are likely to lead to homelessness without immediate assistance (e.g., to pay for utility bill, rent, home repair, etc.)
- Creative solutions to provide affordable housing alternatives for older adults (e.g., rent not more than 30% of income) that are readily available in the near future (e.g., home share programs, rent assistance, ADU incentives)
- Increase support to informal caregivers by improving 211 referrals for older adults, strengthening recruitment and training (e.g., caregiving skills, language skills, or other needs) of IHSS workers, providing a living wage for IHSS workers to ensure a sufficient pool of providers, and other supportive programs for caregivers who do not qualify for MediCal

- Support through adequate staffing and funding the implementation of the county's age-friendly initiative
- Improve accessibility for alternatives to driving by removing financial, physical, environmental, and other barriers to using alternative transportation options (e.g., vouchers for Lyft or Uber, free or reduced fares on public transportation, expanding support for the Senior Companion program or similar volunteer programs to increase volunteer pool of senior companions/escorts)

#### **Action Priorities for 2022**

In 2022, the Commission will:

- Continue to support the county's Age-Friendly Initiative as it conducts community listening sessions and develops an action plan
- Raise awareness of local programs through the online resource directory and monthly Aging Resources Exchange meetings
- Work with the county to address the long-term impacts of the COVID pandemic
- Recruit and orient new commissioners

#### **About the Commission**

The Sacramento County Adult and Aging Commission is comprised of volunteers who track aging trends, monitor services, and listen to input from service providers and the public. The Commission was created to report to the County Board of Supervisors about resources and needs concerning older and dependent adults, their families, and their support networks.

The Commission meets on the fourth Wednesday of each month from 2-4pm. Members of the public are welcome to attend. The Commission is actively recruiting new members.
